Growing Healthy Relationships

Healthy relationships are our main goal here at Response. It sounds like a simple concept but many people have never witnessed a healthy relationship.

Just as you need the right elements to cultivate a healthy and robust garden, the same is true for relationships. Water, sunlight, good soil, patience, positive weather conditions, all of these are needed to make a garden grow. To grow a healthy relationship based on non-violence and equality, you must have eight essential elements:



Non-threatening behavior — talking and behaving in a way that makes your partner feel safe and comfortable when expressing themselves or engaging in activities.



Respect — listening to your partner non-judgmentally; being emotionally affirming and understanding; valuing your partner's opinions.



Trust & support — supporting your partner's goals in life; respecting their right to their own feelings, friends, activities and opinions.



Honesty & accountability — accepting responsibility for self; acknowledging past use of violence; admitting being wrong; communicating openly and truthfully.



Responsible parenting — sharing parental responsibilities; being a positive non-violent role model for the children.



Shared responsibility — mutually agreeing on a fair distribution of work; making family decisions together.



Economic partnership — making money decisions together; making sure both parties benefit from financial arrangements.



Negotiation & fairness — Seeking mutually satisfying resolutions to conflict; accepting change; being willing to compromise.

It's important to note that meeting all of these elements doesn't mean your relationship will be perfect — every garden has weeds — instead, these elements provide the best scenario for healthy growth.

Relationships must be tended to and pruned as these elements cannot sustain themselves. As life's seasons stress a relationship garden with unexpected financial burdens, illness or injury, familial obligations and other strains, it's important to have a resilience reserve and a plan in place for responding to these pressures. Remember, Response is a great resource for your healthy relationship gardening needs — we provide our own tools!


Moving Beyond

Volunteer Spotlight

Response volunteers assist staff with outreach, advocacy, and supportive services. Without help from our volunteers, it would be extremely difficult for our small staff to provide the amount of programming and services we offer. 2018 is a banner year for two of our volunteers. Response Board President, Clare Ellis, is in her final term and volunteer court advocate Susan Carlson will celebrate her 10th anniversary as a Response volunteer! We took a moment to touch base with both women to ask them about their experiences volunteering for Response.

<u>Clare Ellis</u> - We asked Clare how Response evolved in the time she's been volunteering and what Response moments, goals, or achievements she is most proud of since becoming president of Responses Board of Directors. Here's what she shared:

Response began as a grass roots effort by volunteers in the County, to support and assist victims of domestic violence and sexual assault, to find safe shelter and resources for them, should the victim wish. From county residents opening their hearts and their homes to provide that safe shelter, to motel rooms when housing in private homes was no longer feasible, to being given space at the Shenandoah County Farm, to procuring and owning our own space, Response has come a long way! We began in 1980 with volunteers who helped clients to obtain services to where we are now, a professional staff and shelter that continues to serve clients effectively and efficiently. I am particularly proud that I was invited to be a part of this growth, the result of which has been to help clients find their way through victim status to reach the goals that they, the clients, set for themselves.

My family moved to Shenandoah County during the summer of 1984. Much to my surprise, I found that a friend, Billie Lively, who had been our neighbor in Vienna, VA was a neighbor again and was part of the grass roots effort to form Response. Billie and other volunteers, who came from New Market to Strasburg, worked diligently to address the needs of victims of domestic violence and sexual assault, something that was not being addressed by any other organizations in the county. Billie explained the Response concept and asked me to become a board member. That was the beginning of what is now 34 consecutive years as a proud Response volunteer and my second stint as board president.

<u>Susan Carlson</u> - We asked Susan about her volunteer role at Response, what prompted her to volunteer and what she enjoys most about the experience. She shared this with us:

I was looking for something to fill what I thought would be extra time when my children adventured off to discover their worlds. I am a court advocate and a CAP volunteer--- I consider myself to primarily be support to staff--- especially in these two areas. I think it is very important to maintain a physical presence in areas of the community that we have been invited into- maximizing our potential to provide support services. I am honored to be involved with such a great group of people who give their time, their compassion, and their resources to be of service to each individual's special needs.

Our courtroom volunteers assist the Court Advocate in providing accompaniment to Response clients for various incidences that are tried in the Juvenile & Domestic Relations courtroom. Child Assault Prevention (CAP) volunteers assist our Child & Youth Services Coordinator in child assault prevention programming at our local elementary schools.

Community Donations Help Sustain Response

A Letter from Response Executive Director, Jennifer Morrison



It is the time of year when Response needs to review the budget and work with grant funders to determine how much funding we need to carry out our mission next fiscal year. In order to receive grant funds, we have to agree to match a portion of the state and federal funding with local dollars. Response has to match \$62,690 with monetary and in-kind donations this fiscal year ending June 30, 2018. We do not know how much we will have to match next year until the grant cycle is complete and the state finalizes their budget. Matching funds come from donations, local grants, volunteer hours, and fundraising.

This year we face some additional uncertainty. The analysts predict that charitable giving will drop by \$16 billion to \$24 billion (about 6-9%) per year as a result of the new

tax laws. So far, this fiscal year our donations are down 30% from the previous year.

The undesignated monetary donations we receive go to our general funds and we use the money to pay for expenses to run our sexual and domestic violence programs.

We also search for grants that will fund services not available in our community such as transportation. The Shenandoah Community Foundation has graciously given us grant funds throughout the years to assist clients that need assistance with transportation costs. We have also received funding from the United Way of the Shenandoah Valley as well as Shenandoah County to assist us in covering the costs of utilities, life skills training, and maintaining our aging building.

We currently have a grant to assist with legal services which has been a wonderful addition to the current services provided to our clients, as we can now rely on legal representation for matters involving sexual and domestic violence issues.

We will continue to provide as many services as possible with the funding we receive. We collaborate with other service providers in the region to assist those in need and we appreciate all of the support we receive from the community.

How can you help? Partner with us by donating cash, needed items, and supporting our fundraising events.

30 Days of Giving




